Parish Incorporation

The Holy See in 1911 directed dioceses in the U.S. to move toward the civil law model of parish incorporation because it most closely aligned with canon law and the way the parishes already held canon law ownership of their property. Since that time, many dioceses around the country have separately incorporated their parishes and incorporation has become widely accepted as a method of organizing parishes. The dioceses in Michigan that have successfully incorporated their parishes include Lansing, Gaylord, Grand Rapids, and Saginaw. In some instances, civil courts in other states have directed dioceses to incorporate their parishes to reinforce, in civil law, that parish assets belong to the parish, not the diocese.

Our Bishop John Doerfler has already announced that the process of parish incorporation is in our diocese is underway; this process will incorporate every parish in the diocese **as a Michigan nonprofit corporation.** According to church law and theology, each parish and diocese has its own unique set of rights and responsibilities, including the obligation to administer church property. The separate incorporation of parishes is the civil law structure that most accurately reflects ecclesiastical law and theology. Creating nonprofit parish corporations is the simplest and most effective way of ensuring that the rights of parishes regarding church property are respected, not only in church law, but in civil law.

Questions and Answers

What is the present legal structure of the parishes and missions of the diocese?

Under the laws of the State of Michigan, the Diocese of Marquette exists as a "corporation sole." This model is several centuries old and developed out of various historical contexts. This structure civilly recognizes church property as held by the bishop in trust for the benefit of the parishes and other Church-affiliated parties. The corporation sole model is problematic because it gives the false impression that the bishop has ownership of all parish property in his diocese. According to canon law, the goods of a parish belong to the parish itself, and not to the bishop – although canon law does require a pastor to make an account to the diocesan bishop as to how parish property is acquired, administered, and sold. Prior to incorporation, parishes are structured as unincorporated associations under civil law. Is parish incorporation something new or have other dioceses already separately incorporated parishes? Many dioceses around the country have separately incorporated their parishes for many years. In fact, as far back as 1911, the Holy See stated that dioceses in the United States should pursue parish incorporation. Many dioceses have adopted this legal structure as a normal part of parish and diocesan life.

What will it cost the parishes and missions to incorporate?

The diocese will assume the legal costs of filing the articles of incorporation and retitling the property. How will this affect the day-to-day life of the parish or mission?

There should be no substantial change in the normal operation and administration of any parish or mission. The Pastor/Administrator will continue to administer the parish as previously, consulting with the finance council as currently required. The parish will remain in communication with and accountable to the bishop. Permission of the bishop will still be needed when administration of parish goods is an act of major importance according to current diocesan policy and practice. The fact of civil incorporation will not change the basic pattern of parish and diocesan life.

Will there be a board of directors for the parish corporation? If so, who will be the members of the board? Each parish will have a board of directors. The board of directors will be comprised of the pastor (or Parochial administrator or priest moderator), the chair of the parish finance council, and two directors appointed by the pastor. To be consistent with the structure of parishes in church law, the finance council chair and the directors appointed by the pastor will have a consultative vote and the pastor will have a deliberative vote.
